

## admanGo's Data Privacy Statement

This Statement is made by admanGo.com Limited in accordance with the Personal Data (Privacy) Ordinance of the Hong Kong Special Administrative Region ("the Ordinance"). The Statement is intended to notify you why personal data is collected, how it will be used and to whom data access requests are to be addressed.

1. Personal data will only be collected for a lawful purpose, and by lawful and fair means. The purpose for which your personal data and other information may be used include:

- a. the provision of the online application and data services provided to you;
- b. prevention or detection of crime and copyright infringement;
- c. legal proceedings; and
- d. other purposes directly relating to the activities identified above.

2. If you log in to our Services using your Facebook ID, we receive your email address from your social network profile. This email address retrieved from Facebook is compared against our paid subscriber's email address, to load back the subscriber's saved settings in our web application. The web application uses the user token (retrieved through FB log in process) to query Facebook data that he/she interested in real time, and display in a dashboard, and charts for presentation. All the personal information (email address retrieved through Facebook Login, and the user token) is stored in the user's browser cookie only. Web application's saved settings for subscribers will be deleted on behalf of their termination of contract, or on request by the person in charge from the subscriber's company.

3. Subscribers' saved settings, and email address supplied to admanGo will reside in admanGo servers which are protected to the maximum possible extent against unauthorized or accidental access, processing, erasure or other illegitimate manipulation. admanGo servers are, to the maximum possible extent, protected against security attacks over the Internet by means of system securities set up and the "Firewalls". A well-organized and safe system of backups is in place.

4. All reasonably practicable steps will be taken to ensure that personal data held are protected against unauthorized or accidental access, processing, erasure or other use. admanGo shall notify its clients without undue delay after becoming aware of a personal data breach.

5. Your personal data and other information shall be kept confidential. admanGo may, at its sole discretion and for the purpose(s) mentioned above, provide your personal data and other information to: a. any person under a duty of confidentiality to admanGo or who has given to admanGo an undertaking of confidentiality; and b. any person or regulatory or other authority to whom we are under an obligation or duty to make disclosure pursuant to any relevant laws, rules, regulations, codes or guidelines binding on admanGO.

6. Under and in accordance with the terms of the Ordinance, you have the right to: a. check whether admanGo holds your personal data and right of access to such data; b. require admanGo to correct any data relating to you which is inaccurate; and c. ascertain admanGo's policies and procedures in relation to data and to be informed of the kind of personal data held by admanGo.
